1 LeasePak Enhancements

The following sections outline all enhancements introduced in LeasePak UX 4.3a. When noted, an enhancement may not be available to a LeasePak user without the purchase of an associated module. If you are interested in any of these modules, please contact your Product Support Representative for module pricing.

Base System Enhancements

Asset Payoff: NPV Method Added

SPECIFICATION

NPV Asset Payoff Method

The user can now select the Net Present Value (NPV) method for an Asset Payoff in the Payoff [U0103] and Payoff Quote [U0213] updates. This enhancement is supported for leases with irregular payments and AAPR or RAPR accrual methods. To activate this feature, the switch Asset Percentage Calc Method (A/P) must be set to 'A'. This switch is located in the Miscellaneous Customization option of the Custom General [U0712] update.

IBL Payments: Apply Overpayment to Principal or Place in Suspense

SPECIFICATION

Principal Pay Down/Suspense Switch

Overpayments to IBLs can now be either applied to the principal as a pay down or placed in suspense. The switch Principal Pay Down (Y/N) in the Miscellaneous Customization option of the Portfolio [U0212] update is used to make the selection. Setting the switch to 'Y' applies the overpayment as a principal pay down. Setting the switch to 'N' places the overpayment into suspense.



Payment Reschedule: Reverse Deferrals

SPECIFICATION

Payment Reschedule – Deferral Reversal

Deferrals made to a lease through the Payment Reschedule [U0104] update can now be reversed. The new adjustment method Deferral Reversal (DEFR) has been added to the options in the Adjustment Method drop-down menu.

Sale of Asset in Inventory: Reverse Sale of Asset

SPECIFICATION

Reversal of Sale of Asset from Inventory

Now sales of assets through the Sale of Asset in Inventory option of the Payoff [U0103] update can be reversed. A new option, Sale of Asset in Inventory Reversal, has been added to the Payoff options menu.

When a sale of asset reversal is performed, the asset is put back in inventory, all G/L transactions from the sale are reversed, cash is credited accordingly, and a new suspense item is created to replace any suspense cleared during the transaction. This reversal is not possible after the Historical Payment UPD/DTX Clean-Up has been run through End of Period.

VIN/License Plate Search: Paid Off and Terminated Assets Included

SPECIFICATION

VIN/License Plate Search for Paid-Off/Terminated Leases

In Client Search, LeasePak will now display leases with paid off or terminated assets when the VIN or License Plate search option is selected. Lease and asset information that is deleted as a result of running Closed Lease Clean-Up [U0419] during End of Period will not be displayed.

Enhancements to Optional Modules

Application: Tax Credit Trade-In Field Added

SPECIFICATION

Tax Credit Trade-In

The Application Tracking [U0801] module now includes a field for the Tax Credit Trade-In amount in tab 7 of the application. This field works in tandem with the 3.3a enhancement *Up*-*Front and Monthly Tax Handling*.

Collection and Recovery Queues: Assign to Multiple Portfolios Auxiliary Address: Regional Codes Added

SPECIFICATION

Multi-Portfolio & Regional Codes

This enhancement includes two features -(1) Collection and Recovery Queues [U0728] can now be assigned to multiple portfolios, and (2) Regional Codes are now supported by the new [RC] menu option of the Auxiliary Address [U0704] update. Both of these features work in conjunction with Collection and Recovery account assignments.

Collections Lease and Lessee Summary: Fields Added

SPECIFICATION

Additional Fields on Lease & Lessee Summary Screens

This two-part enhancement contains (1) two new informational fields – PAP(Y/N) and Suspense Balance for the lease – in the Collection [U1101] work schedule Lease and Lessee Summary screens, and (2) addition of the DBA name to the toolbar display for the current lessee.

Customer Service Lease Summary: Fields Added Application Inquiry: Broker Activity Status Described

SPECIFICATION

Add IDC & Rates to Customer Service Lease Summary

This enhancement consists of two parts -(1) six new informational fields (Brokerage, Broker Status, Customer Rate, IDC1, IDC2, and Inventory Value) on the Customer Service [U1601] work schedule Lease Summary [F5] screen, and (2) the addition of a line description for the Broker Activity Status in the Application Inquiry [R0502] report.

Application: Data Entry Requirements Function Added

SPECIFICATION

Data Entry Requirements

Application [U0801] now includes a new function, Data Entry Requirements, that can be set up to validate a set of fields according to the application status. Using the feature requires the creation of a Sybase stored procedure to specify the validation rules. Please contact your Product Support Representative for more information.

IBL: Inquiry Report Added

SPECIFICATION

IBL Inquiry Report

A new report – IBL Inquiry [R0927] – has been added to LeasePak. This report features a detail option that will display all principal changes, interest changes, interest adjustments, mid-term



adjustments, and invoice calculations for the selected IBL. The detail option is controlled with the IBL Invoice Detail (Y/N) switch in the Custom General [U0712] update.

Off-Lease Billing: Allowance for Bad Debt Added

SPECIFICATION

Open Bad Debt Allowance for Off-Lease Billing

The Off-Lease Billing module now includes access to the Allowance for Bad Debt field in the Payoff [U0103] update. This field is available for payoffs and terminations of both leases and assets. The Invoice (Rent) field remains accessible as well.

Off-Lease Billing:Payoff Terms

SPECIFICATION

G/L Changes for Off -Lease Billing -Payoffs/Terms

The Off-Lease Billing module now allows the option to choose where the amounts entered into the Invoice/Rent field will be placed in the General Ledger. Currently, they are placed in Operating Lease Income, Lessor Income-Precomputed Finance, or Lessor Income-Simple. When the Off Lease Inventory to Gain Account Y/N is set to Y, LeasePak will place the Invoice/Rent amount in the Gain on Sale of Equipment General Ledger Account.

PAP: Bank Account Name Added for Bank Type WDE

SPECIFICATION

PAP/ACH Back Account Name for WDE

For PAP accounts with Bank Type WDE, the user can now enter a Bank Account Name in the PAP Account Maintenance [U0227] update in cases where the name on the bank account differs from the Lessee Name. The Bank Account Name appears on three reports – Preauthorized Payments Audit [U0304A], PAP Exception [U0304C], and PAP Projection [R0114].

PAP: Update Available for All IBL Accrual Methods

SPECIFICATION

Allow PAP for all IBL Accrual Methods

Payments for all types of IBLs, including loans with both A and B payment methods, can now be processed using Preauthorized Payments (PAP) [U0304], either interactively or through End of Period. Criteria used to select leases and loans for PAP can be modified in the PAP/ACH Control File option of the Portfolio [U0212] update.

New Optional Modules

Lease Summary: Attach External File to Lease

SPECIFICATION

Attach External Files to Lease Summary

The user can now attach an external file to a particular lease number through the Collection [U1101], Alternate, or Customer Service [U1601] Lease Summary [F5] screens. The actual file is stored in a shared directory, while a record of the file and its associated lease number is stored in the RFA table of the LeasePak database up until the lease is cleared through Closed Lease Clean-Up [U0419]. File types that can be attached using this feature are Microsoft Word (DOC), MS Excel (XLS), JPEG (JPG), bitmap (BMP), and Portable Document Format (PDF).

1999 JULE Fund: Enhancement Collection

The 1999 JULE Fund enhancement collection includes the features below. In order to receive any of these features, the entire 1999 JULE Fund module must be purchased. Please contact your Product Support Representative for more information on participating in the JULE Fund or on purchasing this collection.

If the 1999 JULE Fund is one of your purchased modules, proper execution of the Off Lease Asset [U1001] report requires that you initialize (enter through each screen of) the End of Period Customization option in the Portfolio [U0212] prior to running End of Period [U0401].

Automatic Lease Extension: Advanced Invoicing Added

SPECIFICATION

Advance Invoicing

Leases can now be set to continue advanced invoicing from initial term through renewal. The switch Advanced Invoicing (Y/N) in the Automatic Lease Extension [U0108] update is used to activate the advanced invoicing.

Lease Extension: Change Book Depreciation for all Assets on Lease

SPECIFICATION

Depreciation in Lease Extension

Changes to Book Depreciation and Book Salvage Value can now be made at time of lease renewal for all assets belonging to a particular lease. Lease Extension and Automatic Lease Extension [both U0108] include this new functionality, which applies to leases being extended from operating to operating or from finance to operating accounting methods. This enhancement works in conjunction with *Termination: Change Book Depreciation for all Assets on Lease* described below.



End of Month: Pre-Accrue and Pre-Invoice through Last Day of Month

SPECIFICATION

Month End Accrual Invoicing

As long as End of Month is submitted within the five-day window prior to the actual last day of the month, LeasePak will now pre-accrue and pre-invoice all leases with due days between the submit day and last day of the month.

Suspense: Accounting and Reporting Enhanced Associate Item with Application Partially Clear Item through Updates

SPECIFICATION

Suspense Item Accounting & Reporting

This enhancement incorporates several changes to the Suspense functionality, including: (1) suspense items can now be associated with applications; (2) selection criteria for the Suspense [U0109] update and the Suspense Review [U0203] report now include Application and Lessee Number, and these fields, along with Lessee Name, Customer Number, and Group Number are now displayed in both the update and report; (3) suspense items can now be partially cleared through the Payments [U0102], Payoff [U0103], and Book Lease [U0101] updates; and (4) a new report, Suspense Item [U0208], will display changes made to suspense items.

Termination: Change Book Depreciation for all Assets on Lease

SPECIFICATION

Off Lease Book Depreciation Methods

Changes to Book Depreciation can now be made at time of lease termination for all assets belonging to a particular lease. This new functionality is controlled through the Change Depreciation at Term (Y/N) switch in the Miscellaneous Customization option of the Portfolio [U0212] update. Finance assets associated with the lease will be converted to operating accounting methods.

NOTE: This enhancement does not function if the Vehicle Finance module is in use.
