# 1 Notes

### LeasePak Client Memory Requirements

MSI has updated the memory requirements for computers running the LeasePak client software. Refer to *System Requirements* (docsuite/sag/general/system\_requirements/system\_requirements.htm) in the *System Administration Guide* for more information.

### **Search Function**

MSI is now using the program **htdig** to run the MSI Hosted Search. This change does not affect how the Search function is accessed or used from the Documentation Suite. The htdig software is also available if you wish to host a documentation server at your own site. Refer to the Documentation Suite Reference (docsuite/shared/pdf/docsuite\_ref.pdf) and contact your MSI representative for more information.

## **Documentation Changes**

#### **Document Generation**

The *LeasePak Reference Guide* now includes a new version of the Document Generation (DocGen) document, along with a link to the document from the *Reference Guide* Table of Contents.

#### dx Generation

DocSuite now includes a new version of the dx Generation (user) document, including the new screens. The document is located in docsuite/shared/dxgen, or you can access it from the *LeasePak Reference Guide* or *System Administration Guide* tables of contents.

#### **mPower Documentation**

The document *mPower Server* in the *System Administration Guide* (docsuite/sag/mpower/mpserver/mpserver.htm) now includes information on installing mPower in conjunction with J2EE (as opposed to Java/Tomcat).

An updated Java Call Reference is now available (docsuite/developer/api/api\_callref/index.html).

An expanded and revised web services document, *LeasePak API Web Services*, is now available, located in docsuite/developer/api/web\_services.htm.

Documentation also now includes the API Document Type Definition (DTD) containing all supported fields and a sample XML input file. Samples can be found in docsuite/developer/api/samples.

#### Multi Asset Maintenance [U0230]

The *LeasePak Reference Guide* now includes documentation for the Multi Asset Maintenance [U0230] update, along with a link to the document from the *Reference Guide* Table of Contents.

#### **User Defined Client [U0229]**

The *LeasePak Reference Guide* now includes documentation for the User Defined Client [U0230] update, along with a link to the document from the *Reference Guide* Table of Contents.

## **Enhancement Changes**

### 516011/516092 Changes to Enhancement 513296

LeasePak now consistently calculates and displays the Optional Residual in Application/Application Asset [U0801] and Lease Summary [U1601]. Also, LeasePak can now calculate percent of schedule based on either the payment amount or asset cost, as determined by the A/P/C switch in Custom General [U0712].

### 516013 Changes to Enhancement 513295

LeasePak now automatically populates the asset payment amount during Book Lease [U0101] if the total of the asset payments is \$0, allows the entry of \$0 payment amount during Add Asset [U0101], and requires that the asset payment amount is populated during Asset Add-on [U0113].

## **mPower Changes**

mPower Changes affect **Channel/T** and **Serv/T**, the end-user interfaces, and **Link/T**, the LeasePak API. Contact your MSI representative for more information.

#### Summary of Changes from Version 5.1a to 5.2a

- Removed SERVER\_BASE\_URL from web.xml. This is now determined internally, which allows the user to more easily install and configure the web server.
- Removed SERVER\_ROOT from web.xml. Now called APPLICATION\_ROOT, the server determines its value during the web application startup.
- Removed LOGFILE\_DIRECTORY. Now all log files are put in WEB-INF/logs. The directory WEB-INF is not viewable via the browser and therefore not accessible to the general user.
- Removed docgen\_localdir and docgen\_webdirectory, as they are now set internally. Documents are now in /mpower-docs.
- Added a new method to the dxGen object that allows the user to set and send the mPower task name. Since dx Generation allows for multiple environments, this enables mPower to generate documents in different environments. LP\* objects still need to be coded to work with this.
- The API now includes new interfaces, allowing the user to send an XML file containing many new fields.
- Some methods in the API were removed for 5.2a, as the API was converted to a code generator in 5.2a, where some methods could no longer be generated. Use of the API in 5.1a was limited, so this should have minimal impact.
- Known methods that have been removed: LPClient object -> setFullAddress1()
- The Java Call Reference documentation was updated to reflect changes in available methods.
- The documentation now includes a Document Type Definition (DTD) listing all fields supported by the API. mPower converts this DTD to an XML schema, which is then used to generate most of the API calls.
- The mPower suite now consists of three parts:
  - Link/T, the LeasePak API and web services;
  - Channel/T, the end-user interface for dealers and salespeople;
  - **Serv/***T*, the customer self-service application.

- Application work schedule now includes the SQL clause order by to sort work schedule records based on settings in the Application user's profile. In addition, users can now sort on the follow-up date.
- The notebook.jsp now has dynamic Year dropdown, so that years shown will always include the current year plus five.
- Channel/T now includes a City Search.
- As of Feb 25, 2005, many discrepancies have been fixed, including:
  - o The method for vendorAccrualMethod no longer overwrites the vendor number.
  - Customer/Group, Rate Plan, Financial Institution, and Insurance Premium edit checks now work properly.
  - o Financial Institution and Notary Fee Payable To look-ups now work properly.
  - o The value for acquisitionCost is now correctly compared to revolvingCreditLimit.
  - Maturity Date is now calculated as Commencement Date + Term.
  - $\circ$  Values for Salesperson Dollar and Volume Percentages are now converted correctly (10 = 10%).
  - Many Recurring Charge discrepancies have been fixed.
  - o Many discrepancies associated with floating rate leases/loans have been fixed.
  - The Investor Accrual Method is now being populated correctly.

# 3 Enhancements

#### 514723 Retain Batch Number After Processing

**Cash Control module:** the batch number used for processing in U0129 is now retained afterwards and can be viewed in Cash Control Payment History [R0926].

#### 516167 Increase Maximum Number of Financial Institutions

LeasePak now allows a maximum of 999 financial institutions.

#### 516139 Enable Cash Control and Vehicle Finance for Leveraged Leases

Cash Control and/or Vehicle Finance modules: LeasePak now allows users of the Cash Control and/or Vehicle Finance modules to work with leveraged leases. This features a new Check Number field in Load Leveraged Table [U0228] (disabled if not using Cash Control), input required for partial terminations where Cash Received is greater than \$0. Batch numbers from these transactions cannot be reversed through Batch Number Payment Reversal [U0102].
