6.50	4132	533826	U0103 asset termination for simple interest accrual method with irregular payment schedule cannot move forward because there is a edit check conflict between 'NONE' and 'EBV' payoff method.
6.50	4131	533819	U0706 - LeasePak displayed "No License Remain" error when trying to add new security for role. The number of seats mentioned in the license file should not impact Role creation in U0706.
6.50	4127	531328	When partial interest is paid (IBL - B method) using Effective Date earlier than Last Invoice Due Date, both the payoff & payoff quote screens show the wrong Payment Outstanding Amount.
