6.70	5033	539346	EOP - Initialization of "SEQ UPD - MATURED Lease INIT" fails EOP "Sequential Updates 1" module.

6.70	5029	539345	U0239: Incorrectly indicating error on PHP tick marks when it shouldn't.
6.70	5028	539157	R1001: Book Value is using the original cost - depreciation for FIN - OPER asset.
6.70	5027	539294	R0607: Running in batch mode, the criteria of ALL portfolios and ALL assessments is not working correctly.
